RE: LOCAL IMPROVEMENT**

I, Mike Koziol, of The City of Edmonton, in the Province of Alberta, do solemnly declare that pursuant to Sections 226 & 396 of the *Municipal Government Act*, R.S.A. 2000, c. M-26 (MGA):

1. The City of Edmonton has given proper notice of intention dated March 17, 2004, to undertake and complete the construction of the L.I. Plans L1 and L2 described in Bylaw 13690;

2. 30 days after the sending of the Notices have now elapsed, and:


3. Declaration of Petition under City Policy C433C – 3.03:
