BYLAW 14833

PLANNING AND DEVELOPMENT DEPARTMENT FEE AMENDING BYLAW, 2007

Edmonton City Council enacts:

1 The following bylaws are amended by this Bylaw:

- (a) Bylaw 11004, Mechanical Permit Bylaw;
- (b) Bylaw 8664, The Edmonton Building Permit Bylaw;
- (c) Bylaw 13138, Business Licence Bylaw;
- (d) Bylaw 12513, City Streets Development Control Bylaw;
- (e) Bylaw 13521, City Streets Access Bylaw;
- (f) Bylaw 10396, Massage Practitioners Bylaw;
- (g) Bylaw 10398, Exotic Entertainers Bylaw;
- (h) Bylaw 12452, Escort Licensing Bylaw; and
- (i) Bylaw 13145, Animal Licensing and Control Bylaw.

2 Bylaw 11004, Mechanical Permit Bylaw, is amended as follows:

- (a) Schedule A, Gas Permit Fees, is repealed and replaced with the attached Schedule A, Gas Permit Fees;
- (b) Schedule B, Plumbing Permit Fees, is repealed and replaced with the attached Schedule B, Plumbing Permit Fees; and
- (c) Schedule C, Heating, Ventilation and Air Conditioning Permit Fees, is repealed and replaced with the attached Schedule C, Heating, Ventilation and Air Conditioning Permit Fees.

- 3 Bylaw 8664, The Edmonton Building Permit Bylaw, is amended as follows:
 - (a) Schedule A, Building Permit Fees, is repealed and replaced with the attached Schedule A, Building Permit Fees; and
 - (b) Schedule C, Hoarding Agreement, is amended by repealing Schedule C to the Hoarding Agreement (Hoarding Rental Fees) and replacing it with the attached Schedule C to the Hoarding Agreement (Hoarding Rental Fees).
- 4 Bylaw 13138, Business Licence Bylaw, is amended as follows:
 - (a) Schedule B, Fees and Referrals, is repealed and replaced with the attached Schedule B, Fees and Referrals.
- 5 Bylaw 12513, City Streets Development Control Bylaw is amended as follows:
 - (a) Schedule B, Application And Encroachment Fees, is repealed and replaced with the attached Schedule B, Application and Encroachment Fees.
- 6 Bylaw 13521, City Streets Access Bylaw, is amended as follows:
 - (a) Schedule A, Schedule of Fees, is repealed and replaced with the attached Schedule A, Schedule of Fees.
- 7 Bylaw 10396, Massage Practitioners Bylaw, is amended as follows:
 - (a) Schedule A, Fees, is repealed and replaced with the attached Schedule A, Fees.
- 8 Bylaw 10398, Exotic Entertainers Bylaw, is amended as follows:
 - (a) Schedule A, Fees, is repealed and replaced with the attached Schedule A, Fees.
- 9 Bylaw 12452, Escort Licensing Bylaw, is amended as follows:
 - (a) Schedule A, License Fees, is repealed and replaced with the attached Schedule A, License Fees.
- 10 Bylaw 13145, Animal Licensing and Control Bylaw, is amended as follows:
 - (a) Schedule A, Fees, is repealed and replaced with the attached Schedule A, Fees.

11 This bylaw comes into force on January 1, 2008.


