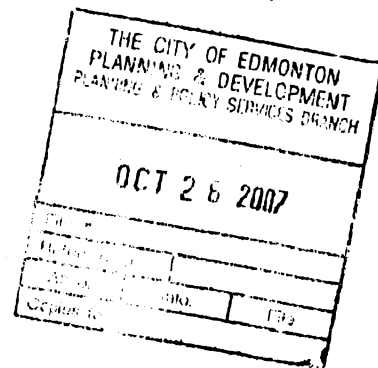

Bill Smith and the writer appeared as a deputation before Naming Committee on Wednesday October 17<sup>th</sup> on behalf of VIP Developments. A series of names had been chosen from the City's approved names list to be reserved for the client's subdivision, including the location within the subdivision and street suffixes. Included in the submission to Naming Committee was the request for consideration of "Whispering River Drive" for the roadway fronting the top of bank lots overlooking the Anthony Henday and the North Saskatchewan River to the north of the subdivision lands.

While Naming Committee has approved the street naming from the names chosen from the City's approved names list, the Committee denied approval of the use of "Whispering River Drive". Our client, VIP Developments, has requested us to appeal Naming Committee's decision regarding the non-approval of "Whispering River Drive" and to request referral of the matter to Executive Committee.


