

Charter Bylaw 20324

A Bylaw to amend Bylaw 12800, as amended,  
The Edmonton Zoning Bylaw  
Amendment No. 3560

WHEREAS a portion of Lot 1, Block B, Plan 2221011; portions of Lot B, Plan 7091KS; a portion of Lot C, Plan 1711MC; and portions of Lot D, Plan 1711MC; located at 13505 - 28 Avenue SW, 2704 - 127 Street SW, 2910 - 127 Street SW, and 3150 - 127 Street SW; Heritage Valley Town Centre, Edmonton, Alberta, are specified on the Zoning Map and Appendix 1 to Section 990 Heritage Valley Town Centre as (AG) Agricultural Zone, (CB1) Low Intensity Business Zone, (RA7) Low Rise Apartment Zone, (RA8) Medium Rise Apartment Zone, and (US) Urban Services Zone; and

WHEREAS an application was made to rezone the above described property to (CB1) Low Intensity Business Zone, (RA8) Medium Rise Apartment Zone, (RMD) Residential Mixed Dwelling Zone, (US) Urban Services Zone, and (PU) Public Utility Zone;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:


1. The Zoning Map, being Part III to Bylaw 12800 The Edmonton Zoning Bylaw is hereby amended by rezoning the lands legally described as a portion of Lot 1, Block B, Plan 2221011; portions of Lot B, Plan 7091KS; a portion of Lot C, Plan 1711MC; and portions of Lot D, Plan 1711MC; located at 13505 - 28 Avenue SW, 2704 - 127 Street SW, 2910 - 127 Street SW, and 3150 - 127 Street SW; Heritage Valley Town Centre, Edmonton, Alberta, which lands are shown on the sketch plan attached as Schedule "A", from (AG) Agricultural Zone, (CB1) Low Intensity Business Zone, (RA7) Low Rise Apartment Zone, (RA8) Medium Rise Apartment Zone, and (US) Urban Services Zone to (CB1) Low Intensity


Business Zone, (RA8) Medium Rise Apartment Zone, (RMD) Residential Mixed Dwelling Zone, (US) Urban Services Zone, and (PU) Public Utility Zone.

2. The Edmonton Zoning Bylaw is hereby further amended by deleting from it the map in Appendix I to Section 990 Special Area Heritage Valley Town Centre and substituting therefore as Appendix I the map attached as Schedule "B".

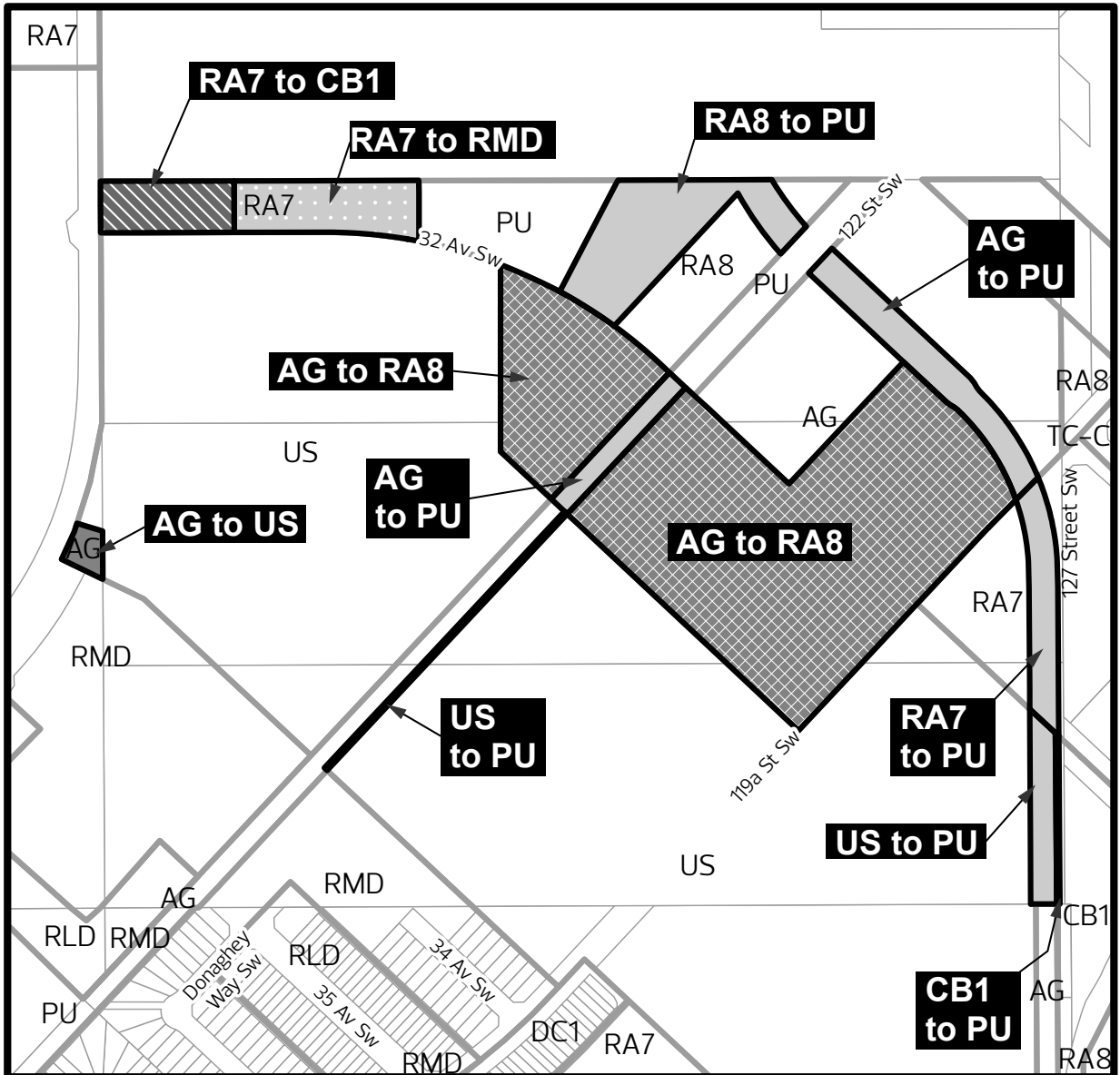



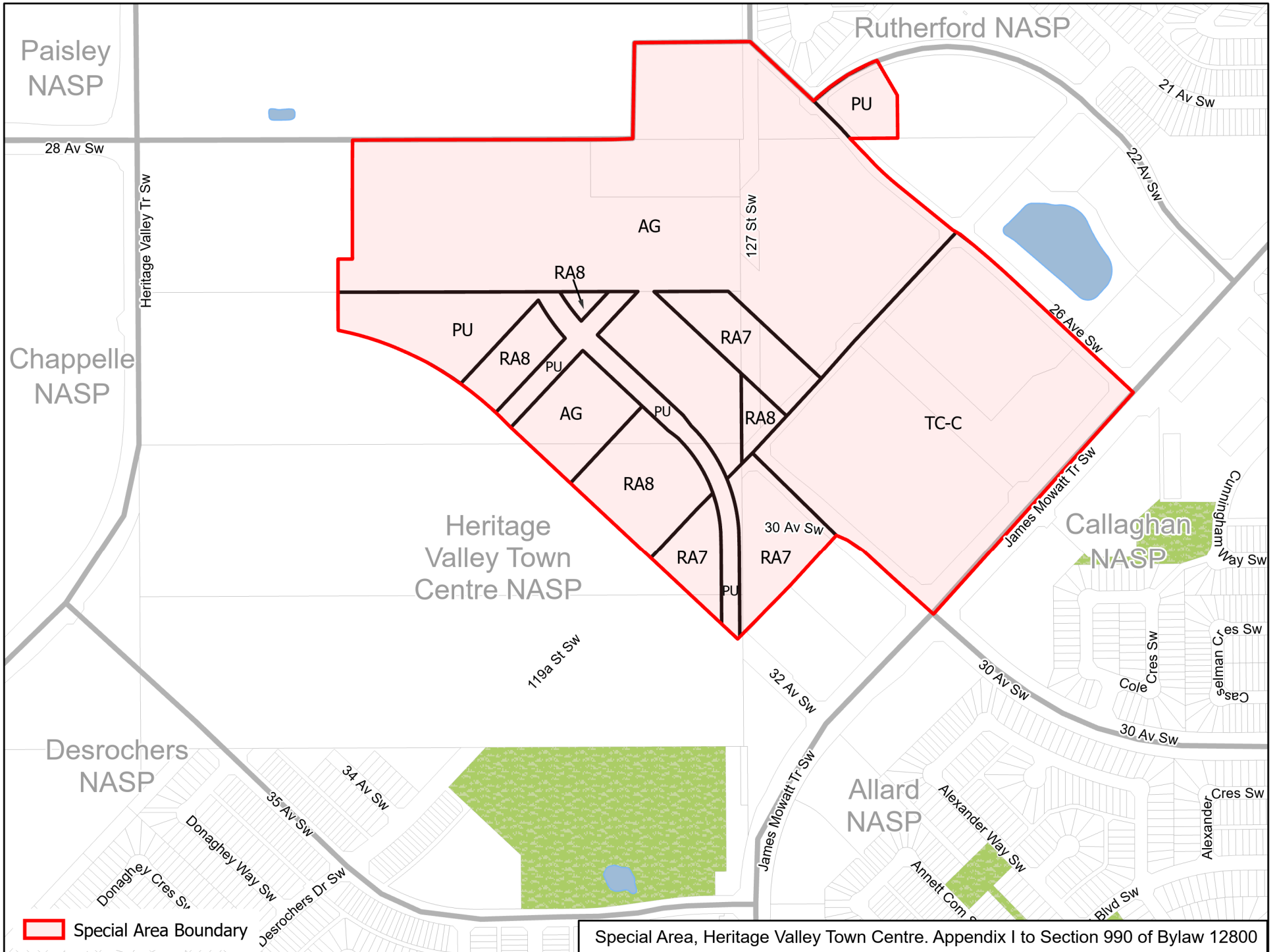
